NWS Holdings selected as constituent of Hang Seng Corporate Sustainability Benchmark Index for five running years

(8 September 2015, Hong Kong) NWS Holdings Limited (“NWS Holdings” or the “Group”; Hong Kong stock code: 659) has been selected as a constituent stock of Hang Seng Corporate Sustainability Benchmark Index (“HSSUSB”) for the fifth consecutive year, with effect from 14 September 2015, reflecting the Group’s continual outstanding performance on environmental, social and corporate governance.

The HSSUSB, launched in 2011, is one of the five indexes under the Hang Seng Corporate Sustainability Index Series that provide a credible benchmark for sustainable investments by measuring the price performance of sizable and liquid Hong Kong and Mainland China listed companies and their sustainability performance. Companies are assessed for its performance on organizational governance, human rights, labour practices, the environment, fair operating practices, consumer issues and community involvement and development. A total of 91 companies have been selected as constituents of HSSUSB in the latest review.

NWS Holdings Chief Executive Officer Tsang Yam Pui remarked, “Corporate sustainability is at the heart of NWS Holdings’ business, and we strive for continuous improvement in every aspect of our operations, including transport, construction and facilities management in our home base in Hong Kong. The Group’s inclusion in the Hang Seng Corporate Sustainability Benchmark Index since its debut reaffirms our position as a sustainable company and underscores the values we have created for our shareholders and the community at large.”
